Persons interested in purchasing any of these parcels shall submit separate sealed bids for each parcel, delivered or mailed to the office of the Town Manager, 15 Sunapee Street, Newport, NH 03773. Separate bids must be submitted for each property the bidder wishes to acquire. All bids must be submitted on the bid form attached hereto.

All bids must be received at the office of the Town Manager by 4:00 pm, August 29, 2016. The bids will be opened in public on August 29, 2016 at the Board of Selectmen's meeting at or about 6:30 pm at the Newport Town Office, 15 Sunapee Street, Newport, NH 03773. Each property will be sold to the highest qualified bidder for that property. The Town will deliver the deed and the successful bidder must pay the balance of the purchase price within thirty (30) days from the date of the bid opening or forfeit the bid deposit.

Prospective bidders may bid on any or all of the listed parcels, but <u>each bid must be accompanied by a bank treasurer's check in the amount of \$1,000 for each property</u> payable to the Town of Newport as a bid deposit. Bid deposit checks will be cashed and credited against the purchase price if the bid is accepted. Other checks will be returned to unsuccessful bidders. The completed bid form and the bid deposit checks must be placed in <u>separate sealed envelopes</u> with the property address of the parcel to which the bid applies noted on the outside of the envelope. <u>Bids must also include adequate proof of funding or financing for the balance of the bid amount and other payments as noted below.</u>

Each bid must be submitted on a form specified by the Town and available at the Town Office and in the "Employment & Contractor Opportunities" section of the Town's web site – www.newportnh.net. Bids must clearly state which property the bid applies to and state the amount the bidder is willing to pay for that parcel. Bidders may submit multiple bids, but each bid must be submitted in a separate sealed envelope with the required bid deposit. All bids must be unconditional, and if accepted, cannot be withdrawn.

Each property is being offered by the Town in "as is" condition with no written or implied warranties as to the condition of the property, the availability of utilities or services or any representation concerning permitted uses under the Town's land use ordinances. The Town does not guarantee that title insurance will be available for these parcels. Properties may not be entered or encroached upon without a Town escort on the date and time listed above. At closing, in addition to the amount bid, the successful bidder must pay a pro-rata share of 2016 real estate taxes computed as if the property were privately owned on April 1, 2016.

The Town will furnish deeds <u>without covenants</u> conveying each property subject to all existing easements and rights-of-way which existed at the time of the tax deeding. The Board of Selectmen reserves the right to reject any and all bids and to impose other conditions on the sales at the time of the bid opening. 
