Winter is Still Here – But Not For Long!



It has been a long, snowy winter and it is not over yet. At one point, snowbanks exceeded 4 feet in height along the runway, completely obscuring runway edge lights. Although the runway was plowed to

the full 50 foot width, the 4 foot snowbanks presented a significant challenge for arriving and departing aircraft. Combined with taxiways plowed 35 feet wide, the airport was somewhat limited in handling aircraft. Fortunately, the extreme conditions lasted only a few days before the town was able to run a snow blower and other heavy equipment to restore better operating conditions.

While springtime conditions are already evident at airports to the south and east, Parlin Field still sports evidence of the long winter. However, airport conditions are changing rapidly as temperatures begin warming. Watch the airport webcam, check NOTAMs, or call the airport for current conditions.

Newport Accepts Runway Funds

The Newport Board of Selectmen voted at their February 21st meeting to accept unanticipated revenue for the purpose of paving the runway at Parlin Field. The unanticipated revenue will come from tenants' prepayment of their ground leases for a period of time to be determined. These funds will be used to repair, shim, and overlay the north 2,850 feet of runway 18/36.

The Airport Advisory Board, with technical input from various sources including the New Hampshire Bureau of Aeronautics, determined that the shim and overlay was the best value approach for improving the runway surface. Detailed investigations had shown that 46% of runway segments rated poor. Only one 200 foot segment rated good, the remainder rated fair. A

detailed report is available on the airport website.

Work on the runway expected to occur during the summer flying season, but every attempt will be made to minimize runway closures. Nevertheless, there will be periods during which the paved runway is out of service, hopefully for no more than 1 or 2 days at a time. We expect the turf runway 12/30 to remain open when the paved runway is closed. As always, check NOTAMs for airport conditions.

Aircraft Registration Benefits Parlin Field

The State of New Hampshire requires that all aircraft based in the State, or visiting for more than 90 days in any year, register



with the New Hampshire Bureau of Aeronautics. This registration process benefits local airports like Parlin Field by returning 25% of the aircraft registration and operating fees to the airport at which the airplane is based. For Parlin Field, the funds we receive are adequate to pay for required inspections and routine maintenance of the aircraft fuel system used by pilots. For those who are required to register with the State, but are not based at any specific airport in New Hampshire year-round, you can designate Parlin Field as your home airport. Funds are returned to the airport you designate. Complete rules are available at the NH Bureau of Aeronautics or see NH RSA 422

Missing Double Points on Your AOPA Card?

Do you purchase fuel at Parlin Field using your AOPA Rewards Card? If so, you are eligible for double rewards points. Parlin Field enrolled in this program more than a year ago, but it seems that some pilots are not receiving double points when using their AOPA card for purchases. We have tried to rectify this problem several times. Ms Gambell will contact Bank of America for you. If you continue to have difficulty receiving double points or any other issues with the self-serve fuel system at Parlin Field, please contact the airport manager.
