APPLICATION FOR CERTIFICATE OF APPROVAL INSTRUCTIONS

1. Approval required for:
Buildings, signs, use of land or buildings and structures (such as, but not limited to, poster panels, exterior lights attached to a building or free standing; walks, curbs; driveways; parking areas; guard rails; fences over 6 feet high; fountains; site and street furnishings; seating; tables; pre-fabricated shelters and planters; trash and litter receptors).
2. Design Criteria:
Colonial, Victorian, Federal, or of another design appropriate to the Common.
3. Copies Required:
 - Submit one (1) copy of the Application.
 - Submit two (2) copies of each item listed below under Paragraph 4.
 - One (1) copy of renderings may be submitted and will be returned to the Applicant at the discretion of the Commission.
4. Submittals Required:
 - 4 -1. Scope of Project: A brief description of the purpose and extent of the proposed work.
 - 4 -2. Site Plan: drawn to scale and accurately locating the building or structure, the property lines, highway rights-of-way, easements, deed restrictions, and all other pertinent information.
 - 4 -3. Drawings: Plans, elevations, and details drawn to scale and clearly showing the intent of the proposed work, including materials and surface finishes.
 - 4 -4. Specifications: Outline the materials proposed, including type and color.
 - 4 -5. Photographs (Optional)
 - 4 -6. Samples (Optional)
 - 4 -7. Other information when necessary to clearly describe the project.
 - 4 -8. Signs: Shall comply with all requirements of the Zoning & Historic District Ordinances; include on the drawings the style of lettering and wording; indicate colors.
5. References:
 - 5 -1. Historic District Ordinance, Town of Newport, NH, including maps of each district; effective March 11, 1980 and October 15, 1996
 - 5 -2 Zoning Ordinance, Town of Newport, NH, amended May 8, 2012
